Thank you for your interest in becoming a Vendor or Exhibitor at ShrimpFest & Craft Brew Hullabaloo, **to be held on March 16th, 17th and 18th of 2018!** Space is limited and sites are assigned on a first come, first served basis, so we recommend reserving your site as soon as possible. Vendor and Exhibitor applications will be approved or denied at the discretion of the ShrimpFest Vendor Coordinator. ShrimpFest & Craft Brew Hullabaloo is a charity fund-raiser that takes place at the Riverview Park in Sebastian Fl. No vendors or exhibitors offering food or beverages for on-site consumption will be allowed. ShrimpFest will provide these items. Vendors are responsible for supplying their own tents, tables, 10lb ABC fire extinguisher, Insurance cert. (see attached) and any additional equipment for their display.

Setup for ShrimpFest & Craft brew Hullabaloo may begin no earlier than the Thursday before the event at **noon** and must be complete by **noon** Friday. Limited security will be available Thursday night.

Each vendor space measures 10' x 10' and all display materials must fit within that area.

ShrimpFest & Craft Brew Hullabaloo Vendor/Exhibitor Application



- ___ Vendors and Exhibitors must not deviate from the products & information described on their application.
- ___ No oversized, unmanageable exhibits will be allowed at ShrimpFest. Vendors and Exhibitors **MUST** keep all their display and materials within their assigned 10' x 10' space.
- ___ Vendor and Exhibitor displays must be staffed always by at least one adult. No children under 18 years of age should be left unattended.
- ___ Vendors and Exhibitors will be required to adjust their display space if requested to do so by ShrimpFest Vendor Coordinator.
- ___ Setup **MUST** be completed no later than Friday at noon. No exceptions will be made.
- ___ Absolutely **NO** vehicles will be allowed in the event. Vendors and Exhibitors **MUST** park in the designated area and move their display items to their assigned space by hand, or with the use of a cart or carrier.
- ___ No pets or smoking is allowed during setup or in the event.
- ___ No soliciting will be allowed outside of your designated area. Vendors or Exhibitors that continue to solicit outside of their areas will be issued an initial warning. If they continue, they will be asked to leave.
- ___ Vendors and Exhibitors are responsible for cleaning their area before leaving the event on Sunday evening. Spaces **MUST** be left in the same or better condition as they were found.
- ___ No water, food or beverage may be sold OR given away from any booth or exhibit. Vendors and exhibitors may bring food and drinks for their own personal consumption within their designated space.
- ___ No adult-oriented merchandise with sexual connotations or merchandise that could be considered drug paraphernalia will be allowed at ShrimpFest.
- ___ Vendors, Exhibitors and Attendees are not allowed any firearms or weapons of any kind for any reason while attending ShrimpFest.
- ___ Vendors and Exhibitors are not entitled to complimentary food or drinks while at ShrimpFest. Food and drink tickets may be purchased at the event's main gate.
- ___ Valuables should not be left unattended. ShrimpFest, event partners and volunteers do not assume responsibility or liability for theft, damage or other loss of property and/or possessions.
- ___ No refunds will be issued due to inclement weather or acts of nature.
- ___ Vendors and Exhibitors will be notified of assigned booth space prior to February 15, 2018. As of March 1st, no refunds will be given. There will be **ABSOLUTELY NO** changes to location if you are not satisfied with your designated site, and registration fee's will **NOT** be refunded. Any refund requests will be approved or denied at the discretion of the Vendor Coordinator.
- ___ Any Vendor or Exhibitor found in violation of these rules and regulations will be required to leave the event without refund of entry fee.
